MEDICAL REGISTRATION ORDINANCE (AMENDMENT OF SCHEDULE 1A) NOTICE 2023

INTRODUCTION

The Registrar of Medical Practitioners (i.e. the Director of Health) made the Medical Registration Ordinance (Amendment of Schedule 1A) Notice 2023 ("the Notice") at <u>Annex</u> under section 14H of the Medical Registration Ordinance (Cap. 161) ("the Ordinance") to recognize the fourth batch of medical qualifications recommended by the Special Registration Committee ("SRC") under the Medical Council of Hong Kong ("MCHK").

JUSTIFICATIONS

2. After the Medical Registration (Amendment) Ordinance 2021 came into effect upon gazettal on 29 October 2021, non-locally trained doctors who possess the recognized medical qualifications, subject to their fulfilment of certain criteria, may apply for special registration to practise in the public healthcare institutions (i.e. the Hospital Authority, the Department of Health, The University of Hong Kong and The Chinese University of Hong Kong) in Hong Kong. After serving for a certain period, obtaining recognized specialist qualifications and passing the assessment, they will be granted full registration to practise in Hong Kong. For non-locally trained medical graduates who possess the recognized medical qualifications but have yet to undergo internship outside Hong Kong, subject to their fulfilment of relevant criteria, they may take the Licensing Examination of the MCHK in order to apply for special registration to practise in the public healthcare institutions in Hong Kong. They may also obtain full registration after meeting the requirements

applicable to all special registration doctors. In November 2021, the SRC was established under the MCHK in accordance with the amended Ordinance to determine the list of recognized medical qualifications after reviewing programmes offered by non-local medical schools with quality comparable to those provided by the two medical schools in Hong Kong. The SRC will submit the list to the Registrar of Medical Practitioners for promulgation by legal notice.

3. Under section 14F of the Ordinance, when determining the list of recognized medical qualifications, the SRC will consider and recommend a medical qualification –

- (a) that is at the level of degree or higher;
- (b) that is awarded by a body broadly comparable to any local university in terms of international rankings; and
- (c) that is broadly comparable to the medical qualifications awarded by any local university in terms of
 - (i) curriculum of the programmes leading to the medical qualifications;
 - (ii) medium of instruction of the programmes; and
 - (iii) any other aspects the SRC considers appropriate.

As for other considerations, the SRC opines that the medical qualifications should be recognized by the medical regulatory authorities in respective places and the duration of the programmes leading to the medical qualifications should be on par with that for the medical qualifications awarded in Hong Kong.

4. In order that the list of recognized medical qualifications could be determined early, the SRC has engaged the Hong Kong Council for Accreditation of Academic and Vocational Qualifications to support the relevant work. After detailed examination, the first three batches of 75 medical qualifications in total recommended by the SRC were announced in 2022. The SRC has earlier submitted to the Registrar of Medical Practitioners the fourth batch of 25 medical qualifications recommended for recognition. Hence, the SRC has so far recommended a total of 100 medical qualifications. The SRC is pressing ahead with the assessment of other non-local medical programmes that fulfill the

stipulated criteria in order to determine the next batch of recognized medical qualifications.

THE NOTICE

5. The Notice is made by the Registrar of Medical Practitioners under section 14H of the Ordinance to amend Part 1 and Part 2 of Schedule 1A to the Ordinance to recognize a total of 25 medical qualifications recommended by the SRC. Part 1 applies to persons who have not yet enrolled on a recognized medical programme as contemplated under section 14D(1) of the Ordinance, while Part 2 applies to persons who have enrolled on or completed a recognized medical programme as contemplated under section 14D(2) of the Ordinance. Since three of the recognized medical programmes in the fourth batch have ceased to admit new students, these three medical qualifications are only added to Part 2 of Schedule 1A to the Ordinance. In other words, the Notice will add 22 and 25 medical qualifications to Part 1 and Part 2 of Schedule 1A to the Ordinance respectively.

LEGISLATIVE TIMETABLE

6. The Notice will come into effect upon gazettal on 30 June 2023. The Notice will be tabled at the Legislative Council for negative vetting on 5 July 2023.

IMPLICATIONS OF THE PROPOSAL

7. The Notice is in conformity with the Basic Law, including the provisions concerning human rights. It will not affect the current binding effect of the Ordinance and its subsidiary legislation.

PUBLIC CONSULTATION

8. Under section 14F of the Ordinance, the SRC is responsible for making recommendations independently to the Registrar of Medical Practitioners direct with respect to the list of recognized medical qualifications. Therefore, no public consultation is conducted in this regard.

PUBLICITY

9. A press release will be issued on 28 June 2023, and a spokesperson will be available to answer enquiries.

Medical Registration Ordinance (Amendment of Schedule 1A) Notice 2023 Explanatory Note Paragraph 1

Explanatory Note

Under section 14H of the Medical Registration Ordinance (Cap. 161) (*Ordinance*), on receiving a recommendation made by the Special Registration Committee on the medical qualifications to be recognized for the purpose of granting a special registration under section 14C of the Ordinance, the Registrar of Medical Practitioners must recognize those medical qualifications by amending Schedule 1A to the Ordinance (*Schedule 1A*).

2. This Notice amends Schedule 1A to recognize the medical qualifications recommended by the Special Registration Committee.
